Dynamic Coalition Coordination Group (DCCG)

Virtual Meeting #93 | 29 January 2025

Summary Report

The participants of the Dynamic Coalition Coordination Group (DCCG) Meeting #93 focused on the agenda for the upcoming IGF 2025 and discussed the proposed idea of gamification to improve accountability within the DCs. They also discussed IGF 2024, the upcoming sessions, and the timeline for the call for session submissions, and the organization and scheduling of the DCs webinars. Lastly, they reviewed the grouping of the Dynamic Coalitions (DCs) and the need for input into the IGF Annual Meeting with a view to the GDC implementation.

I. Adoption of the draft agenda

The agenda of the DCCG meeting #93 was adopted as proposed and is available in Annex I. The call was co-moderated by the DCCG co-facilitators Jutta Croll and Markus Kummer. The list of participants is attached as Annex II.

II. DCs accountability

The DCCG discussed the follow-up to the meeting held in Riyadh that addressed the issue of DC accountability. One suggestion then was to make sure of gamification expertise to enhance DC accountability. Participants reviewed a demo website prepared by Reyansh Gupta from the Dynamic Coalition on Gaming for Purpose (DC-G4P), Reyansh presented a new feature for the DC Coordinator's homepage with a leaderboard system that tracks engagement and participation. The system assigns points for attending meetings and submitting reports, with the aim of fostering accountability and engagement.

However, there were concerns raised about the system's accessibility for people with disabilities, the variables that are tracked, and the potential for gaming the system. Participants questioned the effectiveness of the system in measuring the overall goals of the DCs. The DCCG agreed to further discuss the system's metrics and potential limitations. The meeting also discussed the importance of considering time zones and the need for a bottom-up approach to establish criteria before implementing a gamification system. It was agreed to send the relevant document to the group for further discussion.

III. Preparation of the first DC Webinar in February

The group discussed a webinar on global AI governance for Humanity's Benefit, with IGF Secretariat sharing a draft prepared by Rajendra Gupta and encouraging everyone to provide comments and edits. The team also discussed the potential for future webinars and the importance of accessibility. The meeting focused on the organization and scheduling of webinars for the Dynamic Coalition. It was suggested that the group should continue with the current schedule, with Group 2 organizing for March and Group 3 for April. However, there were some dissatisfactions questions as regards the current grouping of the clusters. It was agreed that the groupings should be reassessed, and it was suggested that this could be a main agenda item for the next meeting. The meeting also discussed the importance of transparency and accessibility in their webinars. Including human captioning. The meeting concluded by extending an open invitation for anyone who wanted to change their group assignment. This could be done via email to the IGF Secretariat.

IV. Preparation for the MAG Meeting.

The meeting also discussed the upcoming First IGF Open Consultations and MAG Meeting, with the IGF Secretariat providing updates on the new IGF 2025 MAG and the next week events. The meeting focused on the upcoming sessions and the timeline for the call for session submissions. It was emphasized not to have a short submission period due to the time required for quality submissions.

The team was encouraged to join these meetings to provide input. Participants reiterated the necessity to bring up the question of the liaison person with the new MAG during the meeting.

V. Any other business

The meeting discussed the upcoming IGF Annual Meeting in June and the plan to have a webinar each month on one of the five themes. Participants also reviewed the grouping of the DCs and the need for input into the annual meeting with a view to the GDC implementation. The IGF Secretariat agreed to circulate a [Google Doc](#) for the DCs to outline their expected outcomes for the IGF 2025 in Norway.

Next Steps

1. IGF Secretariat to circulate a [Google Doc](#) for DCs to present their expected outcomes for IGF 2025.
2. IGF Secretariat to send out a Doodle poll for the next DC Coordination Group meeting on February 11, 12, or 13, with time options of 10, 11, and 12 UTC.
3. Reyansh Gupta to share the link to the gamification website with the WhatsApp group and mailing list for everyone to sign up.
4. Reyansh Gupta to incorporate the dynamic coalitions who attended today's call into the gamification system and show what it would look like.
5. All DCs to review their current grouping and consider if they want to be reassigned to a different theme.
6. DCs to email the IGF Secretariat if they want to change their group assignment.
7. All participants to review the 2021 paper on DC accountability and prepare for discussion at the next meeting.
8. Group 2 of the DCs to start organizing for the March webinar.
9. Group 3 of 4 DCs to start organizing for the April webinar.
