# Objectives

  - Identify ways to integrate digital governance strategies with national and regional development plans.
  - Promote the use of digital solutions to address social, economic, and environmental challenges in East Africa.
6. Enhance digital literacy and skills development across the region:
  - Discuss strategies to improve digital education and training programs.
  - Explore partnerships between educational institutions and the private sector to bridge the digital skills gap.
  - Promote initiatives that foster digital innovation and entrepreneurship among East African youth.
7. Evaluate the progress of previous EAIGF recommendations:
  - Review the implementation status of action items from past forums.
  - Identify success stories and lessons learned from regional digital governance initiatives.
  - Refine and update recommendations based on evolving regional needs and global best practices.

- **Policy Harmonization:** Work towards aligning national digital policies to create a cohesive regional approach to Internet governance, with a focus on data governance and protection frameworks.
